COMMUNICATION TO FULFILL THE INFORMATION OBLIGATIONS

Hotel Pav operated by company Hotelpro s.r.o., Registration Number: 25649019, with residence in Budečská 17, 120 00 Prague 2 ("administrator") processes personal details corresponding to the Ordinance of European parliament and Board (EU) 2016/679 from the day of 27th April 2016, general ordinance of protection of personal details ("GDPR") and other legislation regulations.

In the purpose of fulfilling legal obligations:

The Subject of the details has the right to access his/her personal details mediated by the Administrator, their correction or delete, possibly processing restrictions, and the right to lead an objection against the processing.

Furthermore, the Subject of the details has also the right to get access to personal details from the Administrator that are connected to the Subjects details and any details the Subject provided to the Administrator. The Administrator, based on the request by the Subject to review his/her details, can provide the details without any unnecessary suspension in structured, regularly used and manufactured readable format or the details could be provided to other named Administrator on the request of the Subject. This right does not apply to the personal details which are not automatically processed.

The Administrator has no intention of providing the personal details to the third countries.

If the Subject thinks that his personal details are being misused, he/she can bring the complaint to the supervisory authority, which for the region of Czech Republic is the authority for the protection of personal details (www.uoou.cz).
